






Fig 4. Transient thermal impedance from junction to mounting base as a function of pulse duration; typical values







Fig 5. Forward transconductance as a function of drain current; typical values





Fig 8. Output characteristics: drain current as a function of drain-source voltage; typical values



Fig 9. Drain-source on-state resistance as a function of gate-source voltage; typical values.



Fig 10. Sub-threshold drain current as a function of gate-source voltage




Fig 12. Normalized drain-source on-state resistance factor as a function of junction temperature.



Fig 13. Drain-source on-state resistance as a function of drain current; typical values




Fig 14. Gate charge waveform definitions



Fig 15. Gate-source voltage as a function of gate charge; typical values



 $V_{GS} = 0\text{V}; f = 1\text{MHz}$

Fig 16. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values






Fig 18. Package outline SOT669 (LFPAK)
