






$$P_{der} = \frac{P_{tot}}{P_{tot}(25^{\circ}C)} \times 100 \%$$

**Fig 2. Normalized continuous drain current as a function of ambient temperature**







**Fig 5. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values**









**Fig 7. Sub-threshold drain current as a function of gate-source voltage** $T_{amb} = 25^\circ\text{C}$

**Fig 8. Drain-source on-state resistance as a function of drain current; typical values** $I_D = 500\text{ mA}$ 



**Fig 9. Drain-source on-state resistance as a function of gate-source voltage; typical values**





**Fig 10. Transfer characteristics: drain current as a function of gate-source voltage; typical values**





**Fig 11. Normalized drain-source on-state resistance as a function of ambient temperature; typical values**





**Fig 12. Gate-source threshold voltage as a function of ambient temperature**





**Fig 13. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values**






Fig 17. Duty cycle definition





Fig 18. Package outline SOT666
