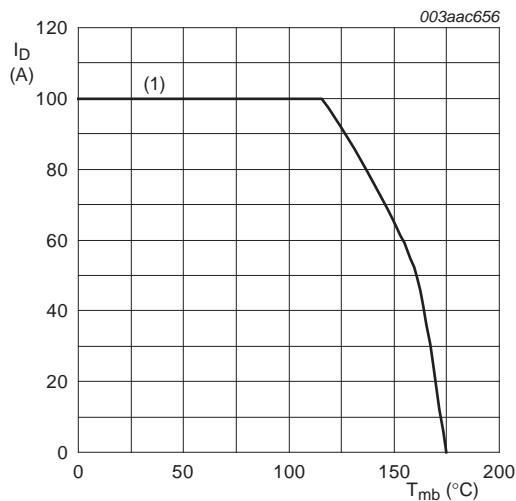

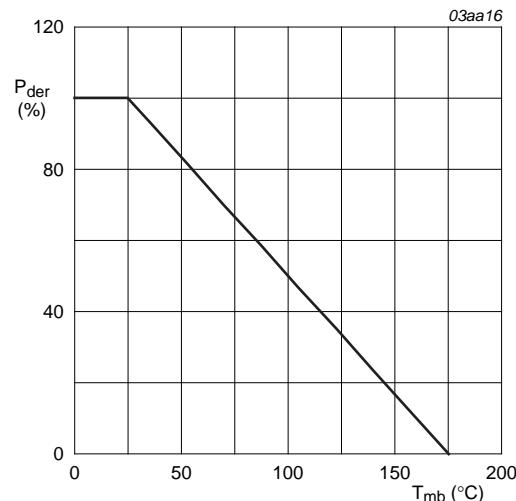

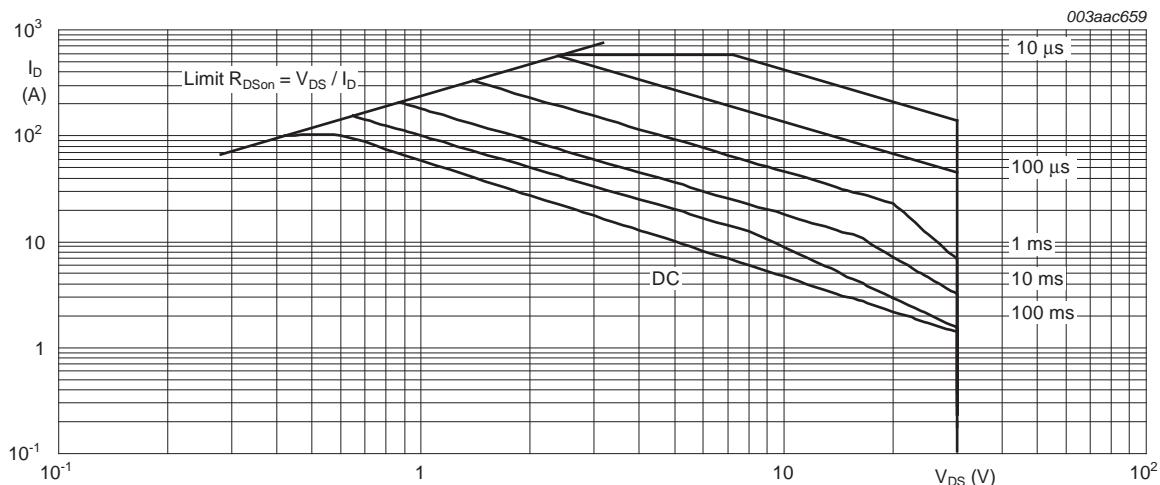

**Fig 2. Normalized total power dissipation as a function of mounting base temperature**



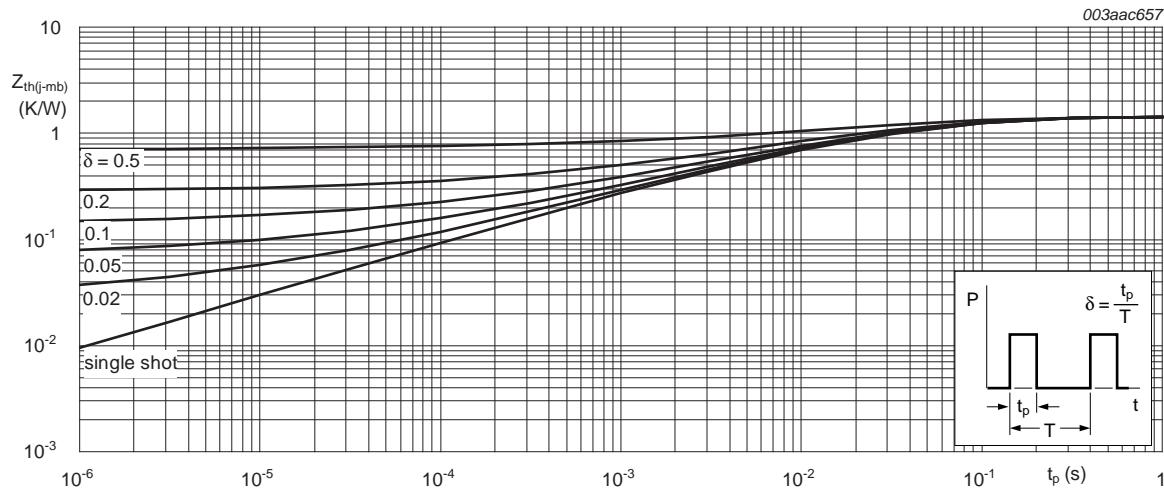

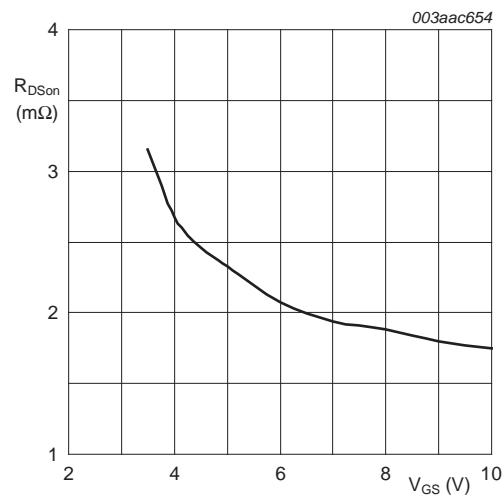

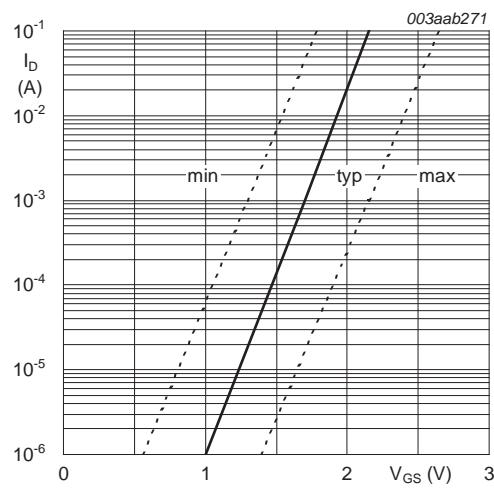
**Fig 5. Transfer characteristics: drain current as a function of gate-source voltage; typical values****Fig 6. Output characteristics: drain current as a function of drain-source voltage; typical values****Fig 7. Forward transconductance as a function of drain current; typical values****Fig 8. Drain-source on-state resistance as a function of drain current; typical values**

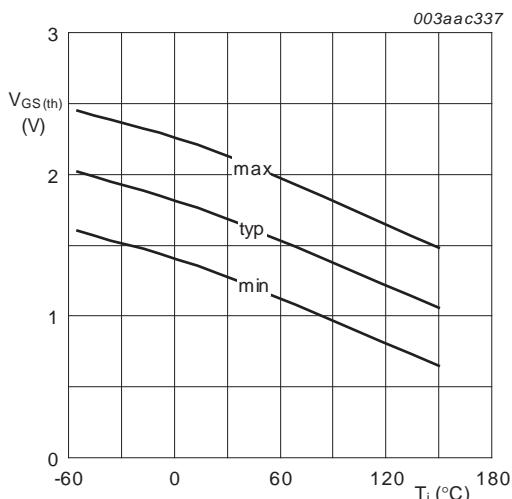
**Fig 9.** Input and reverse transfer capacitances as a function of gate-source voltage; typical values


 $T_j = 25^\circ\text{C}; I_D = 15 \text{ A}$ 

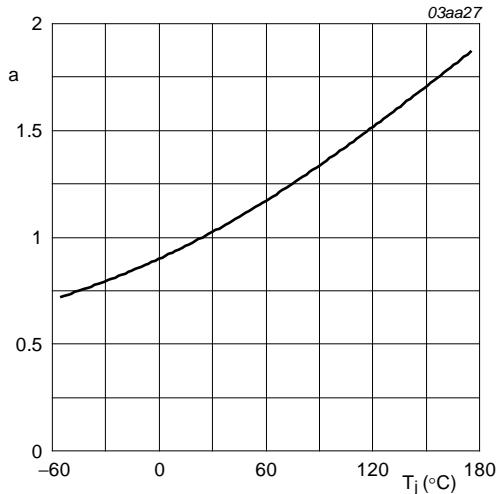
**Fig 10.** Drain-source on-state resistance as a function of gate-source voltage; typical values

**Fig 11.** Sub-threshold drain current as a function of gate-source voltage

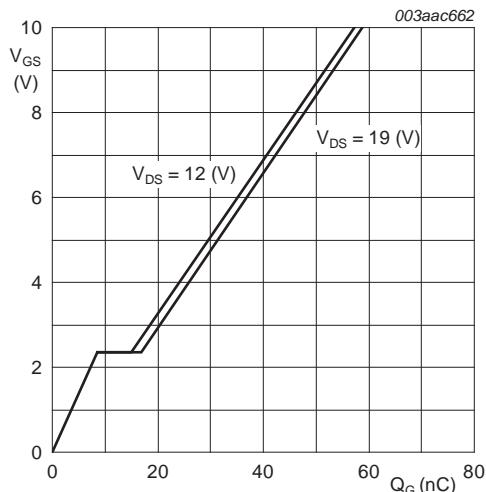

**Fig 12.** Gate-source threshold voltage as a function of junction temperature



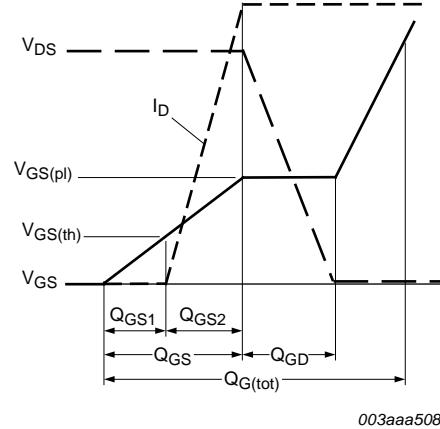

**Fig 13. Normalized drain-source on-state resistance factor as a function of junction temperature**

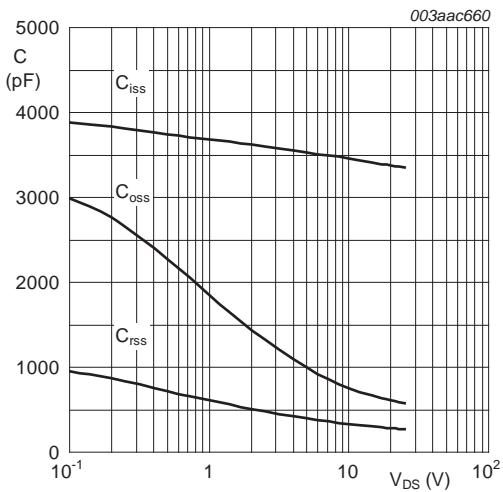

**Fig 16. Input, output and reverse transfer capacitances as a function of drain-source voltage; typical values**

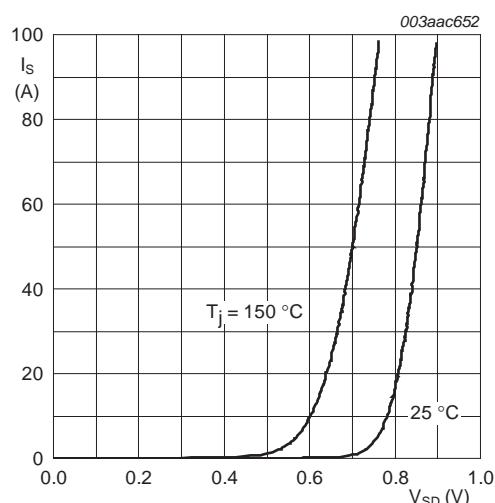

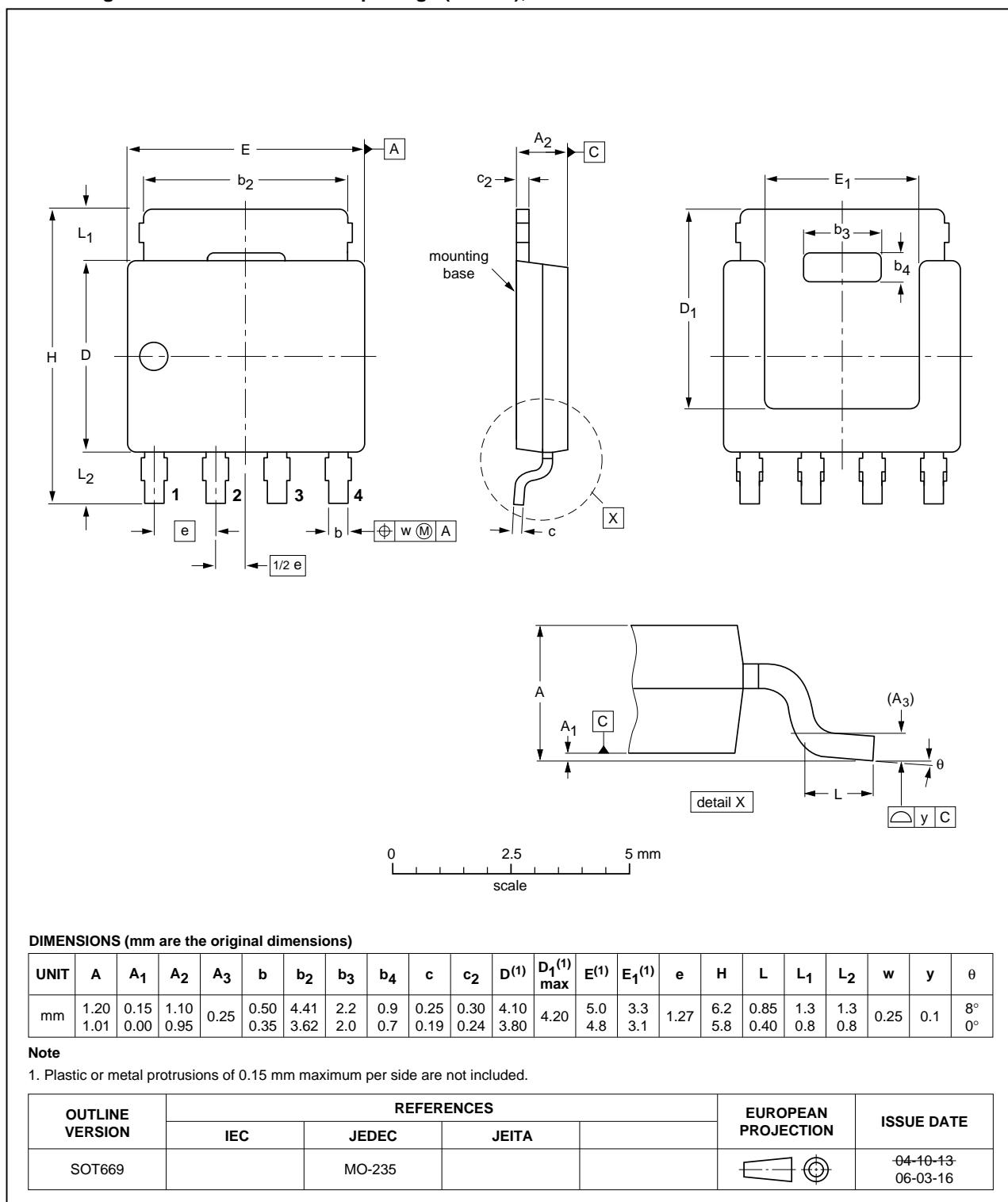


Fig 18. Package outline SOT669 (LFPAK)
