


TYPICAL CHARACTERISTICS $T_A = 25$ °C, unless otherwise noted






TYPICAL CHARACTERISTICS $T_A = 25 \, ^{\circ}C$, unless otherwise noted




On-Resistance vs. Junction Temperature


Source-Drain Diode Forward Voltage




T_J - Drain-Source Breakdown vs. Junction-Temperature






Normalized Thermal Transient Impedance, Junction-to-Case




