Figure 1. Maximum Transient Thermal Impedance




Figure 2 . Max. Power Dissipation vs Case Temperature




Figure 3 .Maximum Continuous Drain Current vs Tc




Figure 4. Output Characteristics





Figure 5. Rds(on) vs Gate Voltage

Figure 6. Peak Current Capability




Figure 7. Transfer Characteristics




Figure 8. Unclamped Inductive Switching Capability




Figure 9. Drain to Source ON Resistance vs Drain Current





Figure 10. Rds(on) vs Junction Temperature

Figure 11. Breakdown Voltage vs Temperature




Figure 12. Threshold Voltage vs Temperature




Figure 13. Maximum Safe Operating Area




Figure 14. Capacitance vs Vds




Figure 15. Typical Gate Charge





Figure 16. Body Diode Transfer Characteristics




Fig. 1.1 Peak Diode Recovery dv/dt Test Circuit




Fig. 1.2 Peak Diode Recovery dv/dt Waveforms




Fig. 2.1 Switching Test Circuit




Fig. 2.2 Switching Waveforms




Fig. 3.1 Gate Charge Test Circuit




Fig. 3.2 Gate Charge Waveform




Fig. 4.1 Unclamped Inductive Switching Test Circuit




Fig. 4.2 Unclamped Inductive Switching Waveforms
