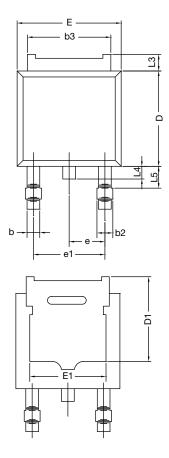
Source-Drain Diode Forward Voltage

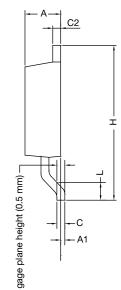
V<sub>SD</sub> - Source-to-Drain Voltage (V)


