


### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






### **MOSFET TYPICAL CHARACTERISTICS** 25 °C, unless otherwise noted





Normalized Thermal Transient Impedance, Junction-to-Foot


