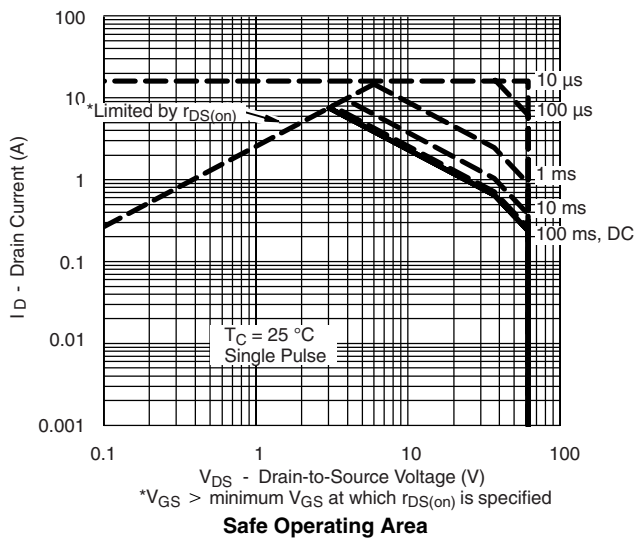
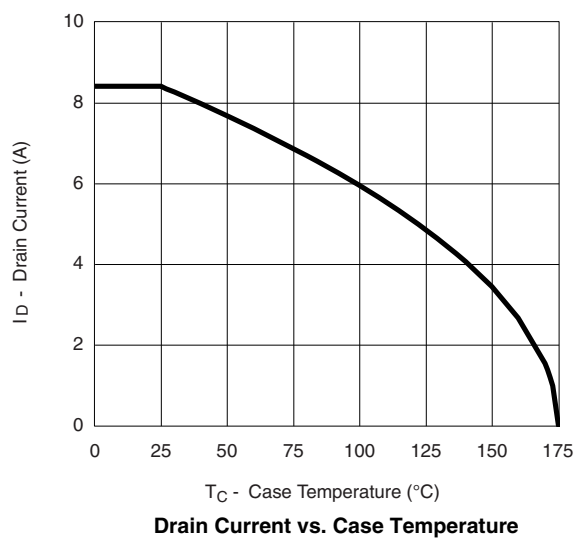
TYPICAL CHARACTERISTICS 25 °C unless noted



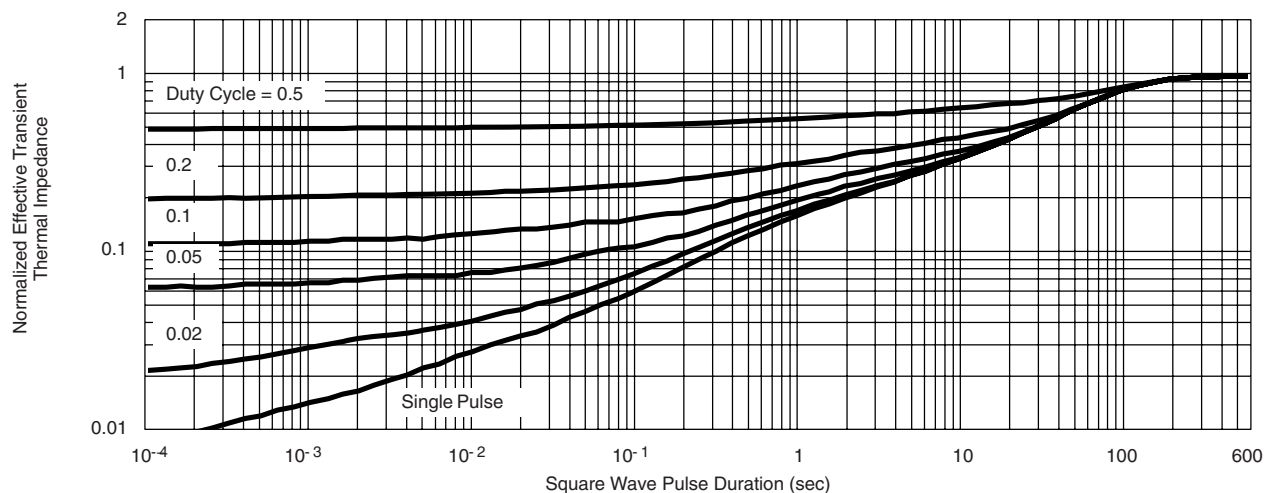

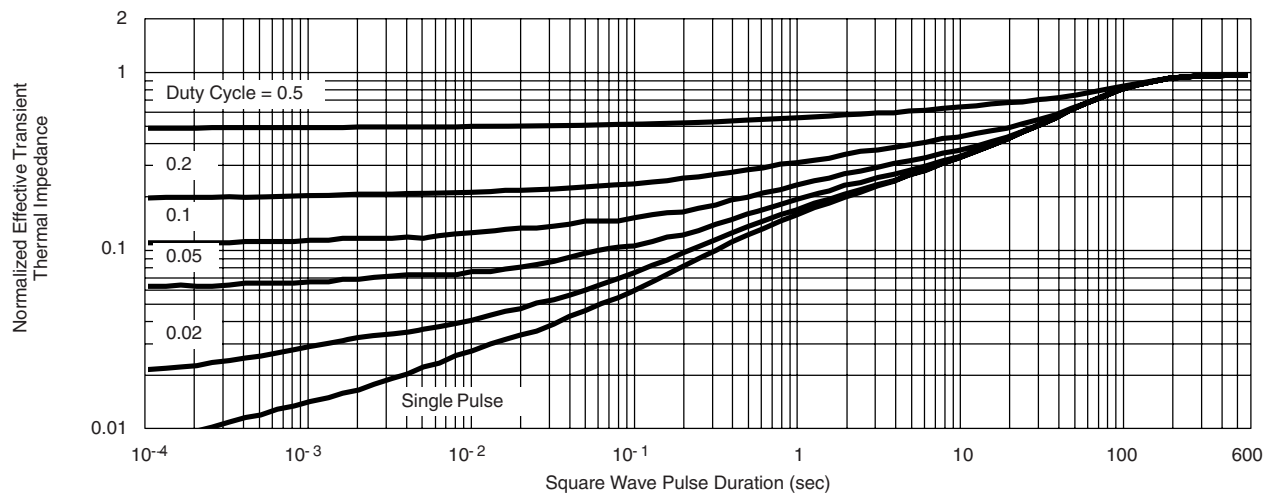

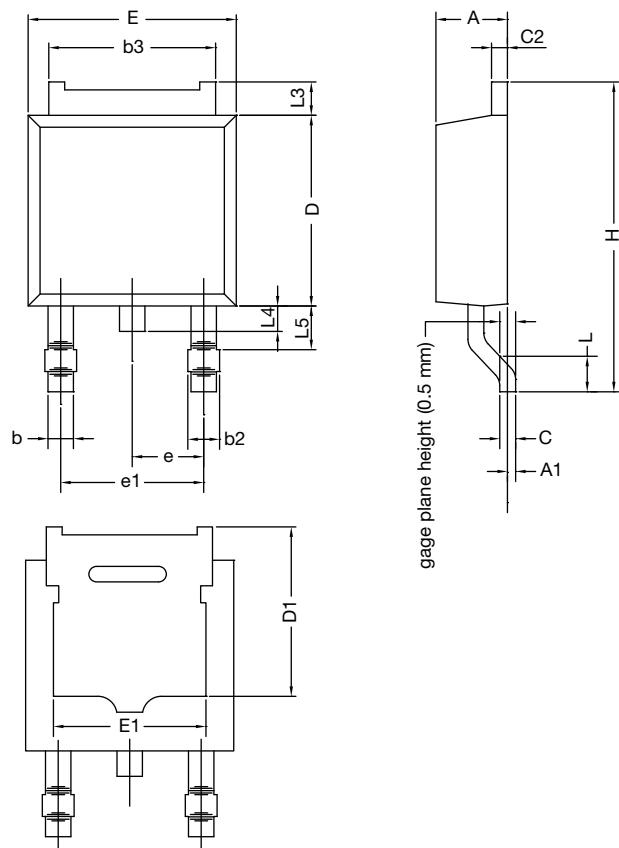


Normalized Thermal Transient Impedance, Junction-to-Ambient

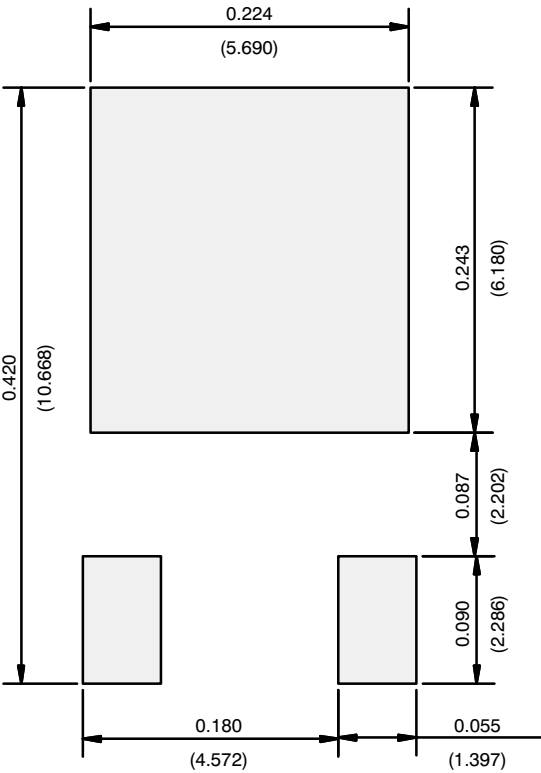
