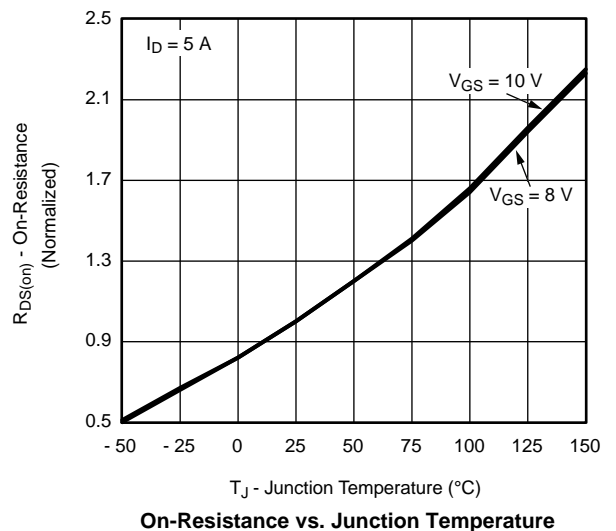
On-Resistance vs. Drain Current and Gate Voltage

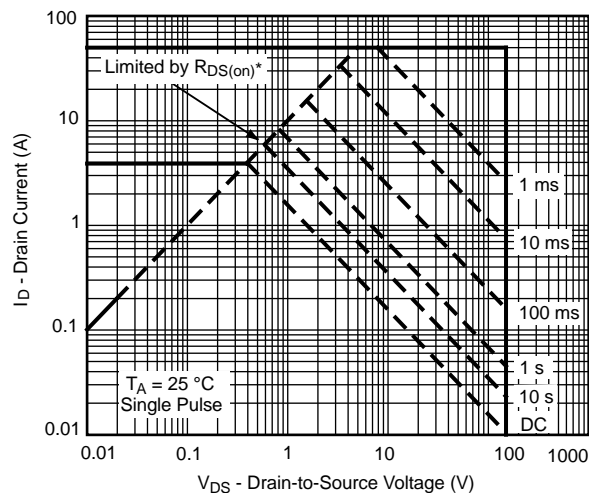
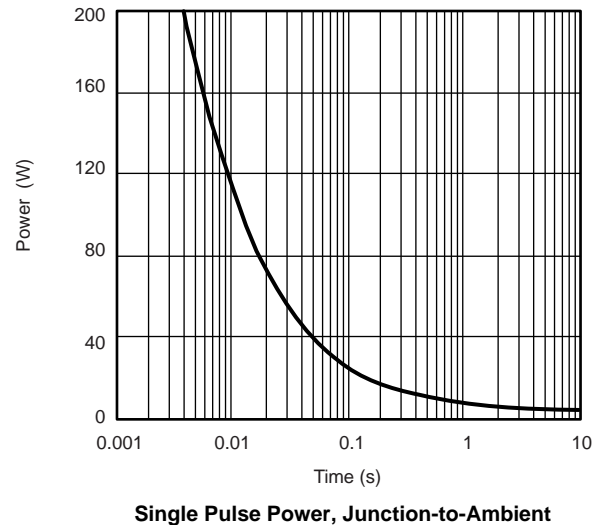
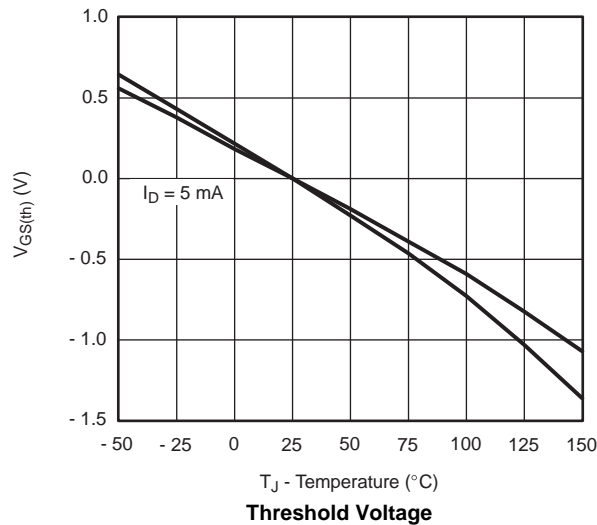
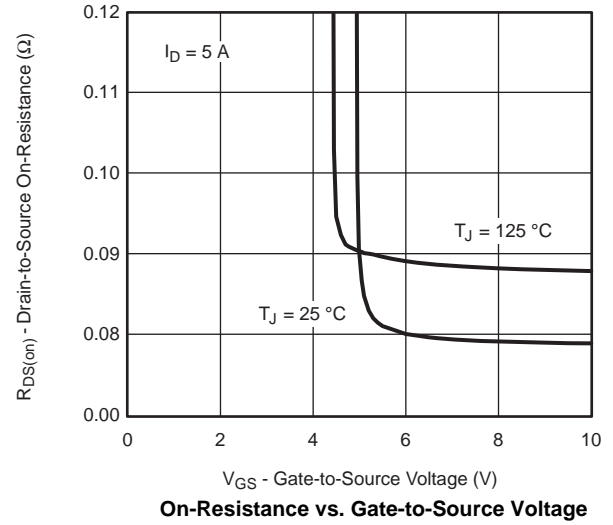
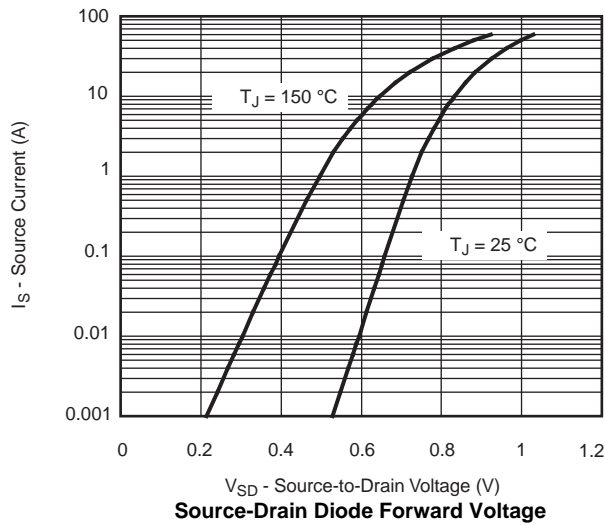


Gate Charge



On-Resistance vs. Junction Temperature

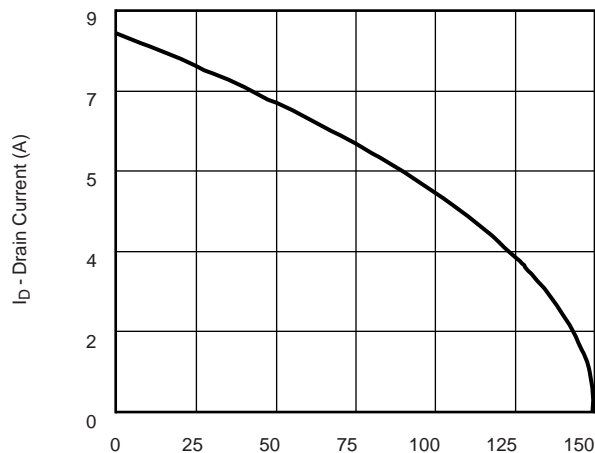

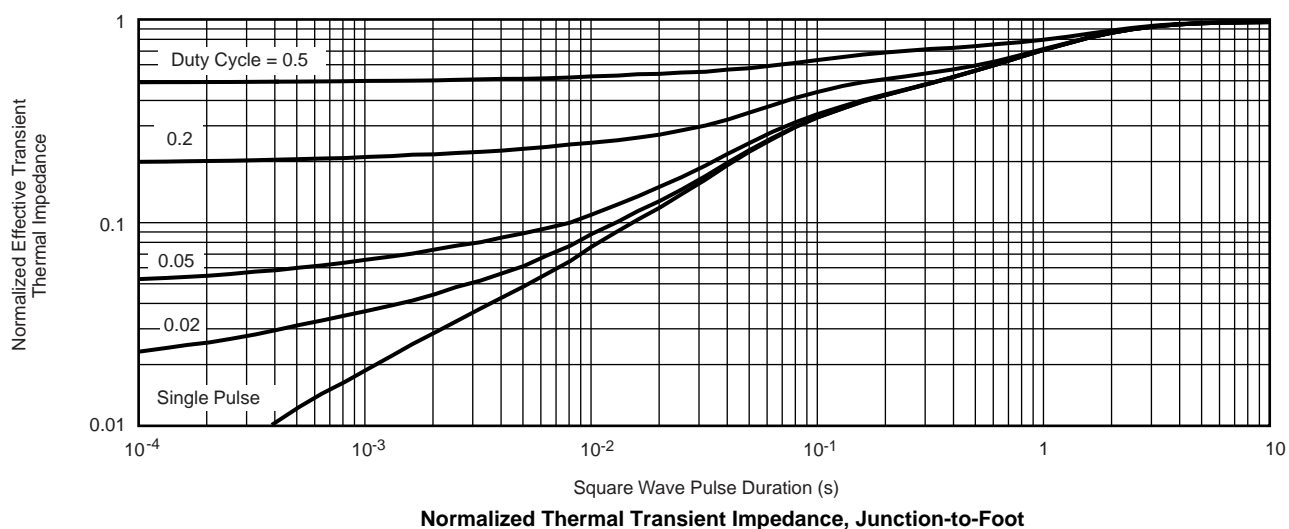
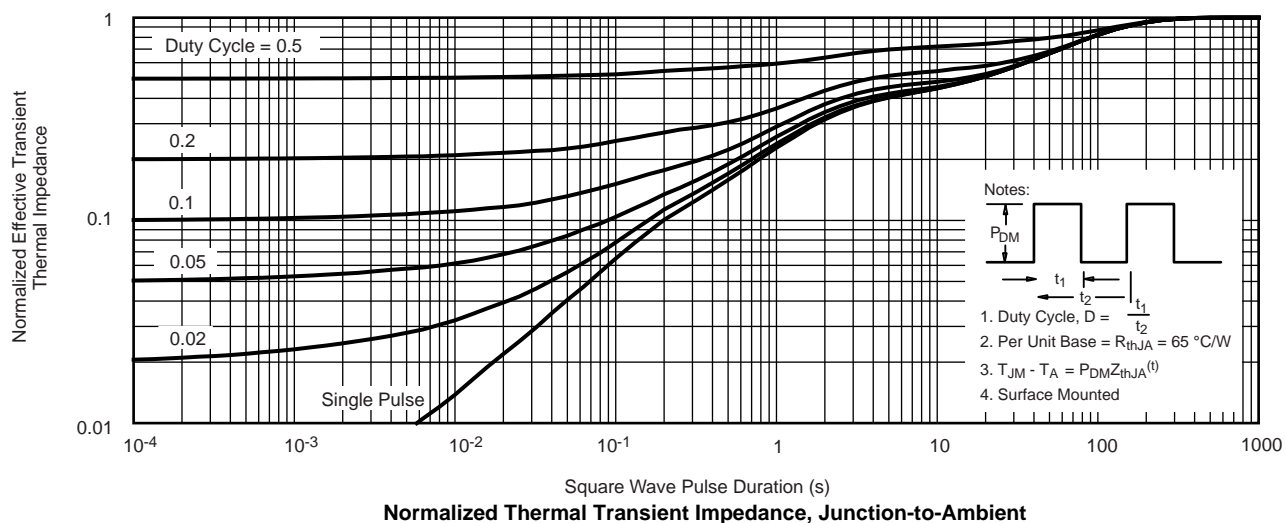
$T_C$  - Case Temperature (°C)  
**Power, Junction-to-Case**



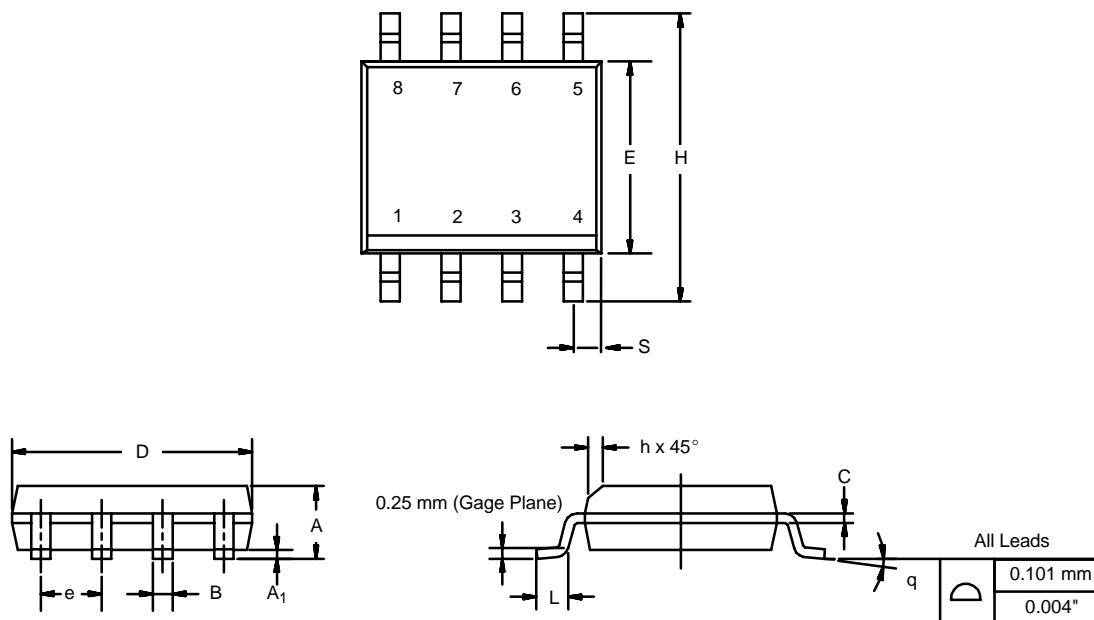
