

TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






V_{DS} - Drain-to-Source Voltage (V) Capacitance


Single Pulse Power, Junction-to-Case



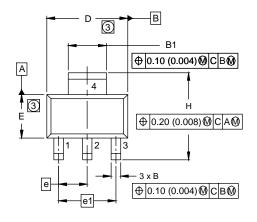
Normalized Thermal Transient Impedance, Junction-to-Foot


